DON'T MISS THE MARCH MEETING OUR SPEAKER... DANA BOWMAN

Time's a-wastin'. Where are my new legs?



On February 6, 1994, Sergeant First Class Dana Bowman, A member of a U.S. Army parachute team known as the Golden Knights, was practicing a maneuver called "thediamond track" over Yuma, Arizona. The precision dive called for Bowman and his partner, Jose Aguillon, to jump simultaneously at 12,500 feet and float a mile apart before switching directions and then flying toward each other to execute a dazzling crisscross. With smoke brackets attached to the men's boots, the maneuver would form a red diamond visible to the air show audience below. "It's difficult," says Bowman, "but the crisscross always has an impact on the crowd."

The partners jumped and split apart. Then Bowman made a pinpoint turn, pulled his arms to his sides, and started hurtling toward Aguillon head-first at an estimated speed of 150 miles per hour. But instead of the planned near miss, the two men slammed into each other. Aguillon died almost instantly. Bowman's legs were ripped from his body--one above the knee and one below, with the billowing smoke bracket still attached to his left boot. The impact caused his chute to open, but he landed unconscious and face-down in a parking lot. A

helicopter sped him to a hospital in Phoenix, where doctors patched him up. Only six days later, Bowman--a muscular Fort Bragg, North Carolina-based Green Beret who apparently has little patience for lollygagging--was loudly demanding his release so that he could attend Aguillon's funeral. After two months, when infection had not cleared from his left leg, he ordered reluctant doctors to remove two additional inches so that he could get on with his recovery. "I hated the wheelchair," he recalls with a mutter.

He then spent 17 frustrating weeks fumbling through eight subpar knee sockets and several pairs of ill-fitting prosthetic legs at the Walter Reed Army Medical Center in Washington, D.C., before visiting an artificial-limb expert in New York. There, Bowman secured a cutting-edge pair of shock-absorberlike legs and several "high-speed flex feet" made of lightweight carbon fiber. In August, just six months after the accident, he was jumping with the team again at the wedding of a friend. He then used a video of the jump to persuade Pentagon brass to let him back in the service--making him the only double amputee ever readmitted to the army. Today, the 32-year-old Bowman, whose medical bills totaled \$250,000, is diving with the team again. He can also switch to different pairs of feet to run, bike, ski, and dance. "I really like to two-step," he says, "so I have a pair that fit into my cowboy boots."

CAMPAIGN ACTIVITIES REPORTING OF VOLUNTEERS HOURS

Remember, to receive the award recognition that clubs and individuals deserve, members must report volunteer hours, Don't hide under a bushel basket! Policy for counting campaign hours. ONLY count hours pertaining to non-paid political activities.

1. Hours as Election Judge, Clerk, Poll Watcher count ONLY if pay is turned over to county party, your local Federated Republican Women's Club, a candidate or the TFRW/PAC
2. Include work done at home, such as mailings, preparing campaign posters or signs, telephoning-solicited by a candidate/campaign, baking for a campaign, but not for club meetings.
3. Count hours spent working at a special event or organizing the event. But NOT if you attend as a guest or if you are compensated for the event
4. Count hours spent in session at precinct, county/district or state party conventions. You may include travel time. NOTE: Please remember to attend your precinct convention!
5. Count hours spent in session at Federation Board of Directors meetings and Federation Conventions also time spent in preparation of convention if on committee. You may include travel time.
6. You may count hours spent as members of county or state party committees – Only during scheduled meeting times. You may include travel.
7. Count political work done at club meetings, i.e., driving a candidate, working on mailings, getting candidate petitions signed, etc. DO NOT count hours in regular meetings.
8. Volunteer hours done at county, state or Federation Headquarters may be counted. BUT NOT for paid staff positions.
9. All hours volunteered at campaigns and at headquarters may be counted. BUT NOT stops for personal errands.
10. Count nonpartisan hours for known Republican candidates in city or school board elections.

11. Women candidates who are members of a club may count their campaigning as volunteer hours as long as no salary is accepted. A separate award will be given in this category at award events.
12. Male associate members may count volunteer hours and must follow the same rules which apply to regular members. Male candidates cannot count hours working on their campaigns.
13. A dual member's hours are only counted in her primary club.
14. Whenever possible, please have your hours verified and initialed by the campaign or headquarters. This will help determine where our hours are most utilized.
15. NOTE: Presidents and Campaign Activities Chairmen are not permitted to work in nonpartisan as well as campaigns when there is more than one Republican in the race. Clubs may not endorse in the name of the club. Individual members may work for the Republican of their choice.

HOURS WILL BE COLLECTED AT EACH MEETING AND MUST BE TURNED IN EACH QUARTER TO TFRW. PLEASE REMEMBER TO KEEP COUNT OF YOUR HOURS.

**MARCH IS WOMEN’S HISTORY MONTH
REPUBLICAN WOMEN’S
CLUBS BEGAN IN 1872**

The story of Republican women's clubs begins many years before women even had the right to vote. Inspired by the Republican Platform of 1872, which said: "The Republican Party is mindful of its obligation to the loyal women of America for their noble devotion to the cause of Freedom ...," Republican women’s clubs were off and running. In fact, the oldest such club on record was founded in Salt Lake City in the late 1800s. Hundreds of independent Republican women’s clubs grew up around the nation in the years to come. For example, there were 140 clubs in Indiana alone by the late 1930s.

It was in 1938 that Marion Martin, assistant chairman of the Republican National Committee, called a meeting at the Palmer House in Chicago to organize these clubs into a national organization. In its earliest days, the Federation was a lobbying group. In 1940, NFRW enlisted the support of its members to urge their representatives in Washington to hold free and open hearings and a full investigation on the amendments to the Wagner Labor Relations Act. They wrote their representatives during National Debt Week to impress them with the fact that constituents were concerned about the national debt. And on June 10, 1940, NFRW President Joyce Arneill sent a letter to all club presidents urging their help in keeping Congress in session until the immediate crisis of the “foreign situation” was past.

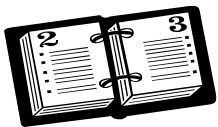
Door prizes were awarded to Sue Melton Jeannie Leonard. Meeting adjourned at approximately 1:00 pm.
